



Memorandum of Understanding

On Academic Cooperation between

Narasingh Choudhury (Autonomous) College, Jajpur, Odisha, India and

School of Environmental Science and Management, Kathmandu, Nepal

This agreement is made and entered into by and between the Narasingh Choudhury (Autonomous) College, Jajpur, Odisha (Affiliated to Utkal University, Odisha, India) an Institution for Higher Education, recognized by UGC and accredited by NAAC and School of Environmental Science and Management (SchEMS), located in Kathmandu, Nepal (Affiliated to Pokhara University, Nepal). The parties hereto agree as follows

- 1. The purpose of this MOU is to develop academic and educational cooperation and to promote mutual understanding between the two Parties.
- Each Party agrees to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
 - 2.1) Exchange of academic and administrative staff
 - 2.2) Exchange of students in ENVIRONMENT AND COMPUTER SCIENCES
 - 2.3) Conducting collaborative research projects
 - 2.4) Conducting lectures and organizing symposia
 - 2.5) Exchange of academic information and materials
 - 2.6) Promoting collaboration in fields of mutual interest
 - 2.7) Promoting other academic cooperation as mutually agreed
 - 2.8) Support graduates to pursue higher studies eg Masters and Doctorate degree
- 3. Each Party agrees to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.
- 4. The respective institution hereby agreed to undertake academic exchange programmes in the above mentioned activities.
- It is understood that the implementation of any of the types of co-operation stated in Clause 2 shall depend upon the availability of resources and financial support of the Parties concerned. Detailed terms and conditions will be developed in consultation of both Parties for the implementation.

Both Parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property rights in any advertising or associated publicity.

- 7. Should the collaborative research activities under this MOU result in any potential for intellectual property, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.
- 8. This MOU may only be amended or modified by a written agreement signed by the representatives of each Party.
- This MOU is valid for a period of five years from the date of signing by the authorized signatories of each Party. Each Party shall review the status of the MOU at least three months before the end of the five-year period to determine whether it wishes the MOU to continue and, if so, any modifications that might be necessary. The period of validity of this MOU may only be extended by the mutual written consent of both Parties.
- 10. This MOU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
- The Parties may disclose certain confidential information to the other in relation to any future proposal made under this MOU. Each Party therefore agrees that the contents of this MOU and the negotiations in relation to any future proposal remain strictly confidential and each Party hereby undertakes not to disclose the same to any third Party, save for its professional advisers, without the prior written consent of the other Party except where such disclosure is required by law (including, without limitation, under applicable freedom of information legislation).
